Job Creation Data Explanatory Notes

Our rationale for the change is twofold. First, due to limits on construction activity imposed as conditions to our local permit, this project's construction schedule has been delayed, meaning the hiring of full-time operations employees has been delayed slightly. Thus, the number of full-time hires as of 12/31 is only one. Second, the number of required OEM wind technicians is slightly less than originally estimated. Originally, according to information from the turbine manufacturer and prior projects, we estimated that we would need 9 wind technicians. Now, we understand that we will only need 7 such technicians.
