Rivian's number of permanent hourly Full Time Employees at the project site was below our agreed upon number of 5,190 Existing hourly Full Time Employees and 100 New hourly Full Time Employees for this reporting period. This was due to natural attrition associated with the launch of our second generation R1 vehicles, which significantly reduce complexity, in tandem with ongoing improvements in manufacturing efficiency and resultant modifications to shift schedules. As we continue our expansion to begin production of R2 vehicles, we anticipate a hiring ramp to begin in Q4 2025, and that we will exceed our target number of hourly Full Time Employees by the end of 2026.
